

ORDINANCE NO. 8315

AN ORDINANCE PROVIDING FOR THE LEVYING OF TAXES ON ALL TAXABLE PROPERTY SUBJECT TO TAXATION IN THE CITY OF MARSHALL, MISSOURI, FOR THE YEAR 2016

BE IT ORDAINED by the City Council of the City of Marshall, Missouri, as follows:

SECTION 1. There is hereby levied on all property subject to taxation in the City of Marshall, Missouri, for the year 2016, the sum of sixty five sixty (.6560) cents on the one hundred dollar valuation thereof as returned by Assessor and the Board of Equalization for said year for General purposes.


SECTION 2. There is hereby levied on all property subject to taxation in the City of Marshall, Missouri, for the year 2016, the sum of twenty eight thirty six (.2836) cents on the one hundred dollar valuation thereof as returned by the Assessor and the Board of Equalization for said year for the purpose of creating a special fund to be known as the "Park Fund" to be used for the maintenance of free public parks.

SECTION 3. There is hereby levied on all property subject to taxation in the City of Marshall, Missouri, for the year 2016, the sum of four thirty nine (.0439) cents on the one hundred dollar valuation thereof as returned by Assessor and the Board of Equalization for said year for the purpose of creating a special fund to be known as the "Band Fund" to be used for the purposes as directed by the City Council. This levy is made under authorization by the vote of the people of Marshall, Missouri, on April 3, 1934, and reaffirmed in April, 1938.

SECTION 4. There is hereby levied on all property subject to taxation in the City of Marshall, Missouri, for the year 2016, the sum of sixteen eighty four (.1684) cents on the one hundred dollar valuation thereof as returned by the Assessor and the Board of Equalization for said year for the purpose of creating a special fund to be known as the "Library Fund" to be used for the establishment and maintenance of a public library. This levy is made under authorization by the vote of the people of Marshall, Missouri, on April 3, 1934, and reaffirmed in April, 1938.


SECTION 5. The City Clerk is hereby directed to extend on the tax books of the City of Marshall, Missouri, for the year 2016, the taxes as in this ordinance provided, and when said taxes are so extended, said tax books shall be by the City Clerk delivered over to the County Collector for collection of the taxes herein provided and levied, and the County Collector shall by said City Clerk be charged with the respective amounts of such taxes shown by said tax books.




BE IT ORDAINED by the City Council of the City of Marshall, Missouri, as follows:

SECTION 2. That the salaries to be paid as set out in said Budget are hereby established for the fiscal year 2016-2017.


SECTION 3. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.



WHEREAS, MCP-Marshall, LLC (MCP) and the City of Marshall (City) previously entered into a Solar Energy Site Lease; and


WHEREAS, MCP and City desire and intend to amend the said Lease.


Section 2. This ordinance shall be in full force and effective from and after its passage and approval.




BE IT ORDAINED by the Council of the City of Marshall, Missouri, as follows:




