## AN ORDINANCE AMENDING ORDINANCE NO. 8734, AN ORDINANCE AUTHORIZING AND DIRECTING THE INTERNAL TRANSFER OF BALANCES BETWEEN CERTAIN CITY FUNDS

**WHEREAS,** pursuant to Section 67.050, RSMo., a political subdivision may transfer any unencumbered balance or portion thereof from the expenditure authorization of one department, office, commission, or other classification to another, subject to such limitations as may be provided by law or charter; and

**WHEREAS**, the City of Marshall now desires to amend Ordinance No. 8734 and authorize the transfer of certain funds within the Municipal Services Department in the amounts stated below.

**BE IT ORDAINED** by the Council of the City of Marshall, Missouri, as follows:

**Section 1.** Ordinance No. 8734 of the Code of Ordinances of the City of Marshall, Missouri, is hereby amended by deleting all that part of Section 1 after the first full sentence thereof and replacing it with the following:

The City Administrator, or his designee, is hereby further authorized and directed to complete an additional transfer of Seven Hundred Fifty Thousand and 00/100ths Dollars (\$750,000.00) from the City's Sanitation Fund to the City's Street Fund in year 2024 and an additional transfer of Five Hundred Thousand and 00/100ths Dollars (\$500,000.00) from the City's Sanitation Fund to the City's Street Fund in year 2025. In each of said years, the additional transfers shall occur within thirty (30) days of February 21.

**Section 2.** All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed. In all other respects, the Code of Ordinances of the City of Marshall, Missouri shall remain unchanged.

Section 3. This Ordinance shall be in full force and effect from and after its passage and approval.
