AN ORDINANCE AMENDING ORDINANCE NO. 8734, AN ORDINANCE AUTHORIZING AND DIRECTING THE INTERNAL TRANSFER OF BALANCES BETWEEN CERTAIN CITY FUNDS

WHEREAS, pursuant to Section 67.050, RSMo., a political subdivision may transfer any unencumbered balance or portion thereof from the expenditure authorization of one department, office, commission, or other classification to another, subject to such limitations as may be provided by law or charter; and

WHEREAS, the City of Marshall now desires to amend Ordinance No. 8734 and authorize the transfer of certain funds within the Municipal Services Department in the amounts stated below.

BE IT ORDAINED by the Council of the City of Marshall, Missouri, as follows:

Section 1. Ordinance No. 8734 of the Code of Ordinances of the City of Marshall, Missouri, is hereby amended by deleting all that part of Section 1 after the first full sentence thereof and replacing it with the following:

The City Administrator, or his designee, is hereby further authorized and directed to complete an additional transfer of Seven Hundred Fifty Thousand and 00/100ths Dollars (\$750,000.00) from the City's Sanitation Fund to the City's Street Fund in year 2024 and an additional transfer of Five Hundred Thousand and 00/100ths Dollars (\$500,000.00) from the City's Sanitation Fund to the City's Street Fund in year 2025. In each of said years, the additional transfers shall occur within thirty (30) days of February 21.

Section 2. All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed. In all other respects, the Code of Ordinances of the City of Marshall, Missouri shall remain unchanged.

AN ORDINANCE AMENDING THE ZONING ORDINANCE OF THE CITY OF MARSHALL, MISSOURI, BY CHANGING THE ZONING CLASSIFICATION OF CERTAIN PROPERTY FROM "R-1" SINGLE FAMILY RESIDENTIAL DISTRICT AND "C-2" HIGHWAY BUSINESS DISTRICT TO "R-2" RESIDENTIAL DISTRICT.

BE IT ORDAINED BY THE Council of the City of Marshall, Missouri as follows:

Section 1. That the zoning classification of a part of the following described property is "R-1" Single Family Residential District, with the remaining part of said property being zoned as "C-2" Highway Business District. Pursuant to this ordinance, the zoning classification of the following described property shall be amended from "R-1" Single Family Residential District and "C-2" Highway Business District to "R-2" Residential District:

A TRACT OF LAND BEING A PART OF LOTS SIX (6) AND SEVEN (7) IN BLOCK THREE (3) OF HAGGIN'S ADDITION TO THE CITY OF MARSHALL, SALINE COUNTY, MISSOURI, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A STAKE IN THE NORTH LINE OF SAID LOT 6, SAID STAKE BEING 225 FEET EAST OF THE EAST LINE OF ODELL AVENUE, IN SAID CITY OF MARSHALL; THENCE EAST ALONG THE NORTH LINE OF SAID LOT 6 A DISTANCE OF 222 FEET TO A CORNER POST; THENCE SOUTH 509.2 FEET TO A STAKE AT THE SOUTHEAST CORNER OF SAID LOT 7; THENCE WEST 218.5 FEET TO A STAKE WHICH IS 225 FEET EAST OF THE EAST LINE OF SAID ODELL AVENUE; THENCE NORTH 509.2 FEET TO THE POINT OF BEGINNING.
